RONDOR MUSIC INTERNATIONAL SIGNS TRAK STARZ

Santa Monica, California, August 22, 2003 -- Rondor Music International, has recently signed the red-hot production team Trak Starz, it was announced by Lance Freed, President Rondor.

Trak Starz recently produced and co-wrote the Chingy album "Jackpot" featuring the hit single "Right Thurr." The single held the No. 1 position on the R&R CHR/Rhythmic chart six out of the last seven weeks and currently sits at No. 2. It is also No. 2 on the Billboard Hot 100. The album holds the No. 7 spot on the Billboard 200 and is No. 3 on the Billboard Top R&B/Hip-Hop Albums. The video has had extensive airplay on MTV and BET and was voted No. 1 video on MTV2.
